



1. Release. 2. Assumption of Risk. I am aware of the risks associated with participation in the Zen-K9 Education center events and do hereby voluntarily assume full responsibility for any risk of loss, property damage or personal injury, including death, that may result from participation in event activities.

3. Medical Emergency. In the event of injury or a medical emergency, I understand that the Zen-K9 Education Center officer, trustee, employee or agent, will be responsible for the medical care of all attendees. I understand that this Waiver and Release shall be construed as broadly and inclusively as is permitted by applicable law and agree that if any portion of this document is held invalid, the remaining shall continue in full force and effect.



6. Media Consent.
